## Terms of Reference (TOR) of the Committee: The TOR of the committee shall be:

- 1. To recommend the selection SHGs for providing drones to the MoAFW in accordance with demand for services
- 2. To monitor the performance of the States with reference to Drones provided to SHGs

- 3. To provide technical inputs, support and policy framework for the smooth implementation, selection and monitoring to the states.
- 4. Any other task recommended by the committee.
